# OSCE

- Concept of security (Rule of Law and Human Rights)
- Copenhagen (1990) and Moscow (1991) documents of the Conference for Security and Co-operation in Europe – participating states agreed to develop human rights education programmes and courses for various target audiences – schools students, universities students, civil servants etc.
- 2005 – Decision of the Ministerial Council on promotion of human rights education in 57 OSCE participating states

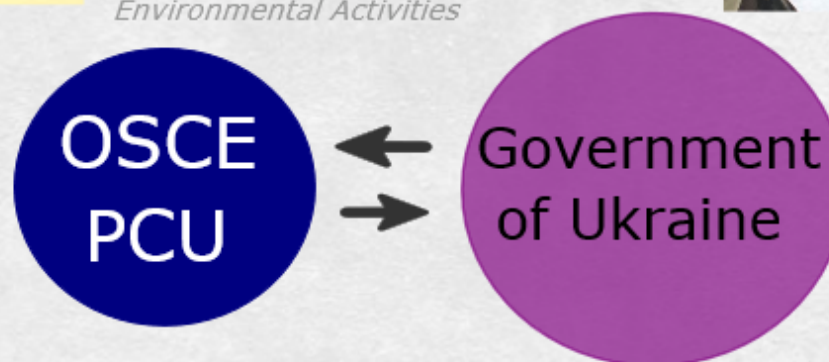

- Development of human rights education materials for students and teachers
- Carrying out human rights training (ToT training for teachers and professional retraining institutions, training for students) – in cooperation with CSOs, Education Ministry and Ombudsperson's office





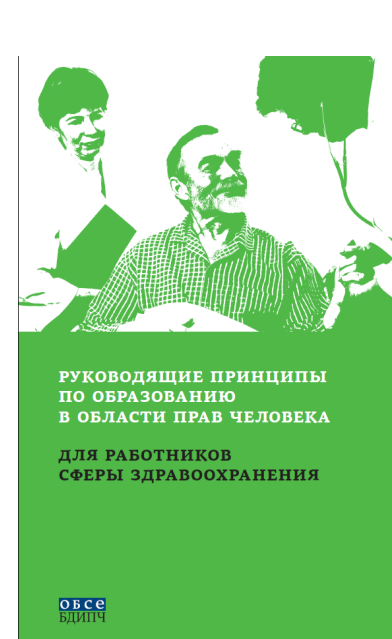
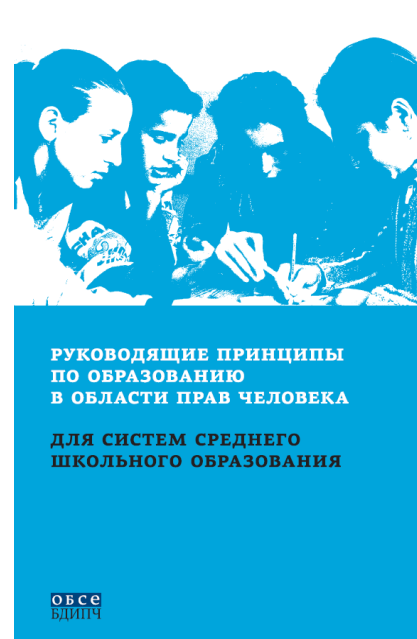
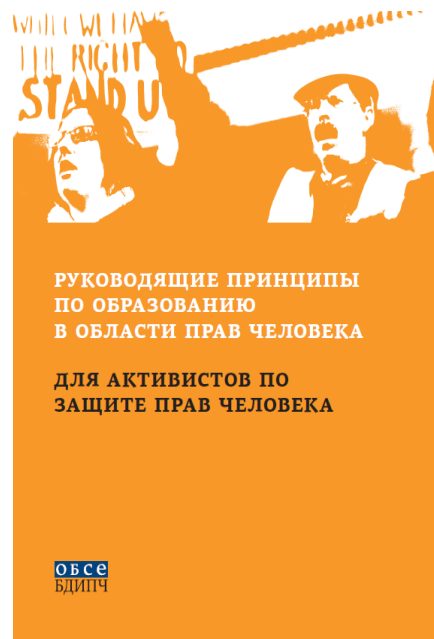
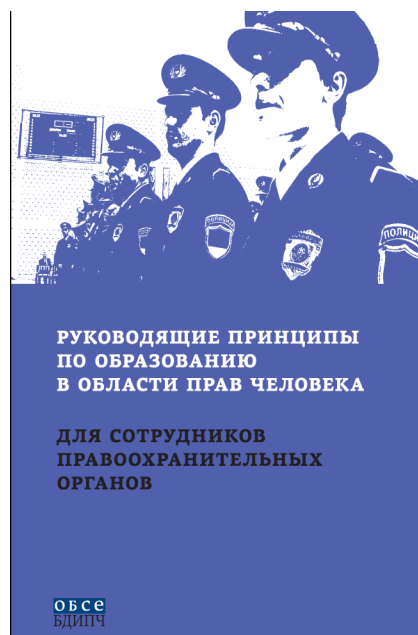
# Programmes development

## **Goal – ensuring established learner outcomes**

### Core competencies

- Knowledge and understanding (what learner is aware of)
- Attitude and values (what learner demonstrates)
- Skills (the learner is able to)

## Promoting human rights based legal education



- Development of standards of legal education, and quality assurance framework
- Development of human rights oriented content for the core legal courses (Criminal process textbook – focus on the rights of each parties of the criminal process)
- Development of the human rights course and textbook for law students
- Creation of the Centers of Excellence for law professors in Universities (on Human Rights)
- Linking RoL and Human Rights (joint courses and programmes)
- Human rights education and awareness raising activities for students and children (moot courts, forums on human rights, essays competition, human rights drawing contests, human rights summer camps)



## Human Rights training for judiciary and legal professionals , joint trainings with media



Development of the human rights curricula for judges and advocates, joint training events with journalists and judiciary

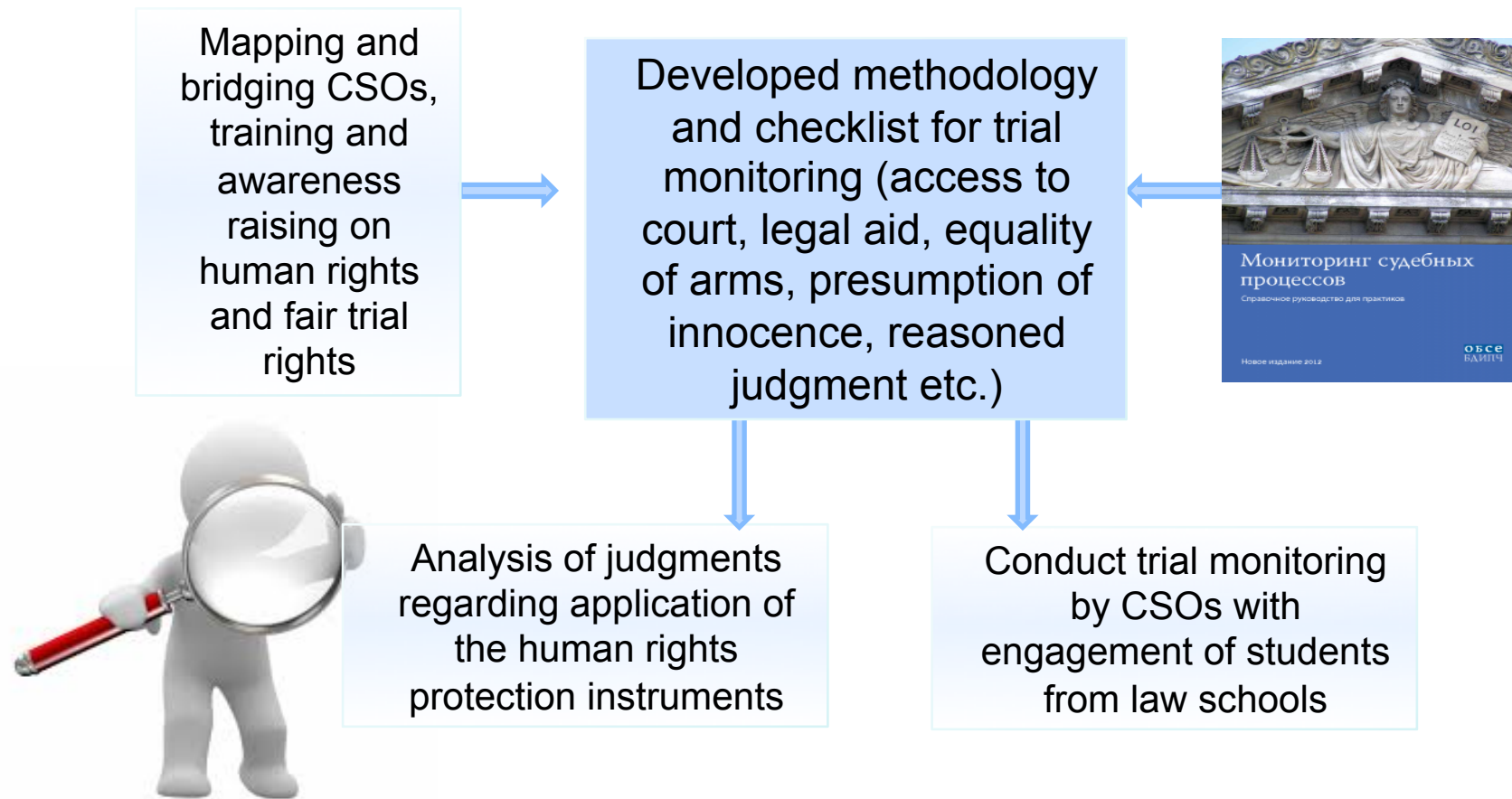


Online courses development, roster of trainers among judges and advocates
